TERMS AND CONDITIONS

1. This Contest is the #हरघरबालगोपाल प्रतियोगिता (“Contest”) on Ishara TV Channel (“Channel”).
2. This Contest is organized by IN10 Media Private Limited (“IMPL”).
3. The promotions and the viewer engagement/ participation shall start from 27th November, 2024 and end on 5th December, 2024 (“Contest Period”). No entries will be entertained post 5th December, 2024.
4. The Contest will run during the airing of the show Jai Shri Krishna (“Show”) on the Channel throughout the Contest Period.
5. The participant agrees and confirms that they have read, understood and by participating in the Contest they accept the terms and conditions stated herein.
